Faith in Action of Marathon County, Inc. is a non-profit organization that provides supportive services, at no charge, to Marathon County seniors (60 and over), regardless of income, religious belief, or ethnic background. Services are provided by trained volunteers to help seniors improve their quality of life and remain independent in their homes for as long as safely possible.

FIAMC began with a grant from the Robert Woods Johnson Foundation, the nation's largest philanthropy devoted solely to improving health and healthcare for all Americans. In the past 30 years, over 1,200 *Faith in Action* programs have been developed in the United States. Today all program funding is secured at the local level.

Our Senior Home Safety Program is designed to help seniors live more safely in their homes. We assist Marathon County homeowners age 60 and over by installing grab bars and/or hand railings to reduce falls within the home. 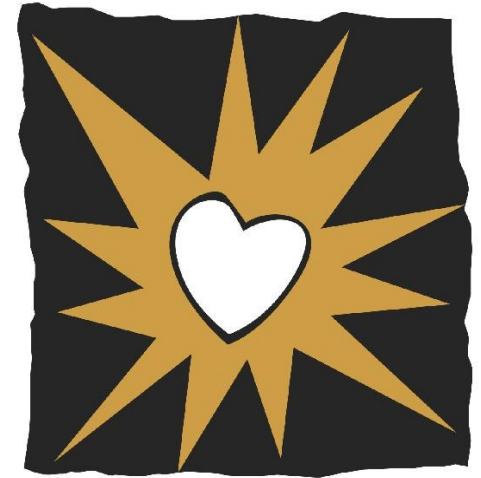
