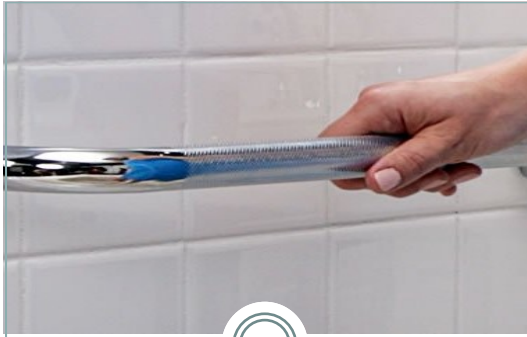

## Senior Home Safety Program

Are you afraid of falling in your home? Would you feel safer with grab bars in your bathroom or hand rails to help keep your balance? Many seniors want to age in place, but a fall could result in a premature move to a nursing home or assisted living facility. Accidental falls are one of the leading causes of injury and death in people over 65 worldwide.

Faith in Action of Marathon County will provide a free home safety assessment and install the necessary home safety enhancements for area seniors. Our trained and skilled volunteers will help you to feel safer in your home with the installation of grab bars and/or hand railings to allow you to live more safely and independently in your home.

## PROGRAM REQUIREMENTS

- Age 60 or over
- Marathon County Resident
- Own your own home

## THE PROCESS

1. **Contact Faith in Action** : Call us at (715)848-8783 to discuss your home safety enhancement needs. If you are a new client, we will meet with you in your home to review our program and see if it meets your needs.
2. **Preliminary Assessment**: A trained volunteer will complete a free home safety assessment of your property to determine the most effective way to enhance safety within your home.
3. **Installation**: A skilled volunteer will schedule a time at your home for installation of the agreed upon home safety enhancements (grab bars and/or hand railings).
4. **Commitment to Safety**: We are committed to choosing the safest option for your home accessibility needs, as well as ensuring the safety of our volunteers.
